FROM THE EDITOR

“And any other duties that might be assigned”

Job vacancies on the railroad were advertised and posted in bulletin books for the various crafts to view. Bidding took place and the job was awarded to the senior employee making the application. The advertisements told of the starting hour, location, pay rate and a brief description of the position. There was always one caveat that was typed at the end of the requirements. The catch all: *“And any other duties that might be assigned”*. That sentence told the employee not to be surprised by any additional work required of him or might be assigned to him in the future.

I was raised a Master Mason in the month of March. I was appointed to Assistant to the Secretary in June and in December I was elected Secretary of Joppa Lodge #362. I saw the garden path but didn't smell the roses. I left the East at Joppa last year and returned to the Secretary's station, thankfully. I never thought I would say Secretary and thankfully in the same sentence.

During this same year, I was a member of the Scottish Rite class when the reunion was held in Marksville, during the month of April. Sometime prior to the Shreveport Valley holding the fall reunion, I was given two scripts, one from the Fourteenth Degree and the other of the Eighteenth Degree, and told to learn speaking parts in each. It might have been during this reunion or possibly the next that I found myself holding additional scripts from Seventh, Twentieth and Thirty Second Degrees and told to learn the parts before our next reunion. I kept remembering that someone from the Scottish Rite, in the upper echelons, had said that Degree cast members would only work in a maximum of two degrees and preferably just one. No really, I distinctly recall that being said to someone who repeated it to someone else who then told...I can't remember right now. I must have stepped out on the garden path when it was mentioned this was all voluntary.

I was blessed to have received Knight Commander of the Court of Honour in November of 2003. I remember the ceremony distinctly. My Wife, Mother and Father were there. I had gotten out of the hospital nine days earlier after cancer surgery-a five day stay, followed by a subsequent visit of ten more days. I was released looking as though I had suffered the penalties of the Master Mason obligation

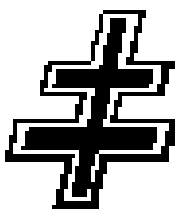

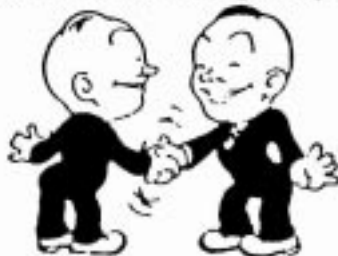

A VISIT WITH ALBERT PIKE

The following is excerpted and reprinted by Permission from Heredom Volume 10

The Scottish Rite Research Society

Contemporary Mason: ...I live in the twenty first century, so much has changed. Can any of this (Pikes Morals and Dogma) still be relevant to my world?

Albert Pike: The world has changed more in government, in society and in science during my lifetime than in centuries before. But let me ask about your world. Is there no more poverty?

Contemporary Mason: We still have poverty.

Albert Pike: Is every boy and girl educated to their full potential?

Contemporary Mason: No, in many ways our academic standards are much lower than they were in your time, much lower.

Albert Pike: You sadden me sir. An ignorant populace is despotism waiting to happen. Have women been allowed to reach their full potential?

Contemporary Mason: That is nearer, but we have done it by pretending there are no differences between men and women.

Albert Pike: That is shocking! Those differences are the glories of both the sexes. Even in my time, those talented and gifted women were taking their places beside men as doctors, scientists, as businesswomen, as teachers, never forgot that they were women...You had asked if the Rite were meaningful in your world. In your world is there no longer exploitation of the working men and women.? Do employers look after the welfare of their workers as they do for their own?

Contemporary Mason: It is better, but it is not as good as it should be.

Albert Pike: Do all men practice the highest standards of ethics? Do men in positions of power refuse to lie, even if doing so is to their advantage? Have men and women learned not to judge each other, but to accept differences as strength?

Do men no longer feel superior to those who have fallen into trouble with the law or into public disgrace? Do they understand that if they themselves have not fallen, it is only because sufficient circumstances and temptations have not come to them?

Contemporary Mason: No, all of that is still with us.

Albert Pike: Ah. Perhaps most important, are religious fanaticism and intolerance gone from your world? Do men no longer attack others because of religious differences. Is each person now willing to let the other find God in his own way and follow the dictates of his own heart and conscience?

Contemporary Mason: We have fallen far, far behind in that. We call them "terrorists" and all over the world, they are

willing to kill because they hate those who do not see things they way they do.

Albert Pike: Then sir, you can answer your own questions. Is a fraternity which teaches men integrity and honesty and honor; which insists on fair and compassionate treatment for all in society, even the lowest and the most poor; which tells men that women are equal inability; which teaches each man that he has no right to feel superior to any other-especially a fraternity which teaches that each human being has an absolute right to independence in thought, no group of men has the right to say "Agree with us or suffer"-is there a need for such a fraternity in your world? Is it relevant?...

Contemporary Mason: ...But some people in my time wonder why, if we're not secretive, not up to doing something wrong, why we don't open our meetings to just anyone.

Albert Pike: Because they have not earned the privilege of being present. Or do people in your time think they should know everyone's private business just because they are curious?

Contemporary Mason: Many do.

Albert Pike: No! When you knocked on my door this evening, sir I greeted you as a Brother. I did not know you personally, but I knew critical things about you, before you entered this room. That ring with a Square and Compasses told me.

I knew that you had asked a Masonic Lodge for the privilege of membership and had filled out a petition.

I knew that at least three men who were already members of that Lodge met with you and talked with you. They spent enough time with you, probably on more than one day, to feel that they knew what kind of person you were and that you were an individual of integrity and honor.

I knew that all the members of the Lodge at the meeting when your petition was read and the Committee reported had voted on you in secret ballot.

I knew that you had passed through all three Degrees of the Blue Lodge. And then you had taken the Degrees of the Scottish Rite, so that even if you were at the beginning of your Masonic journey, you were committed to it.

Membership in Masonry is not a right to be exercised; it is a privilege to be earned. Your treatment as a Mason is not a right' it is a privilege you have earned by the promises you have made to treat others in the same way.

You have earned the privilege of telling me anything you want in confidence, knowing it will not be repeated, because you have promised to respect the confidences of Masons, myself included.

You have earned the privilege of coming to me for financial relief, to the extent that I can if your need is real, because you have promised to do that for other Brethren.

You have earned my trust and confidence because you promised never to cheat, wrong or defraud a Brother.

But sir, the world at large has not made those promises, passed those investigations, proven themselves worthy. They have not earned the privilege, although the Lodge stands to welcome them, if they choose to earn that privilege.

Masonry is not secret; it works in the world to benefit all men and women. But its instruction, its ceremonies, the relationships it builds between Masons of all races, all nations, all walks of life, are private-the earned privilege of its members.

Contemporary Mason: Well yes, but...

Albert Pike: I suspect sir, from your speech and bearing, that you have attended an institution of higher education. Is that the case?

Contemporary Mason: Yes, I have a Master's Degree.

Albert Pike: And would you approve, sir, if your institution gave that same diploma to anyone who asked for it, even though they had never taken a class nor set for an examination?

Contemporary Mason: No, that would make it meaningless.

Albert Pike: You have earned that diploma. It has meaning because it attests to the preparation you have made and the knowledge and understanding you have gained?

Contemporary Mason: Yes.

Albert Pike: Then sir, as I used to say when arguing in court, I rest.

Contemporary Mason: I told you that I had not been a Mason for very long and have been a member of the Scottish Rite for even a briefer time. In my world, we don't seem to like to think that there is anything special about anyone, except maybe those we call "celebrities" or that one person is better than another. Is it really so special, being a Mason?

Albert Pike: Sir, if your world truly sees no distinction between a George Washing and a Benedict Arnold, or between a man who works to help the poor and the powerless, who is a friend and protector of those who have no other friend and protector, and the man who lines his pockets and increases his store of gold regardless of whom he may harm or impoverish, then I weep for what my world has become.

All men may be created equal, and all men should be and are equal before the law; but they are no means equal in what they become, in how they chose to develop, in their character, or in the ways in which they face the vicissitudes of fate.

To me sir, to be accepted as a Mason and a member of the Scottish Rite was the single greatest privilege and honor of my earthly life. Sir, the greatest and wisest men of our world have been members of our Fraternity. You and I are of one brotherhood with such men as Washington, Franklin, John Marshall, Sam Houston, Voltaire, Mozart, so many others. The skies of our world's firmament are illuminated by such stars as these and so many many more. And they glitter there because they, like you and me, swore upon God's sacred altar that they would

live lives of charity, trust, compassion, honor and integrity. To be considered worthy to be in a company of such men...that is very special indeed!

Leadership Time

Hopefully, each and every one of you had a wonderful Sacred Season of Christmas and an enjoyable Hanukkah. We enter a New Year with hope for Peace and good health and wishes for family and friends to be about us as often as possible. We have all had the experience of finishing 2004, and now attempting to write 2005 on all of our documents, checks, letters, etc. It is a retraining that we all go through each year - learning that new date. We practice writing that date by paying the Christmas bills as they arrive. It is an annual ritual.

Another annual ritual in Scottish Rite is the Installation of new officers in each of our Valleys. The Nominating Committees have examined the attendance rosters, looked over up-and-coming workers, contacted the potential officers, received assurances of faithful attendance and participation, and have placed the names on the floor for election, and now, the time for installation of officers.

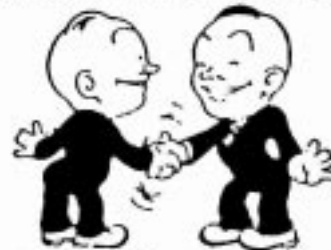

Did You Know?

“Special sessions may be called by the Sovereign Grand Commander to be held at such time and place as he may name in the call. It shall be his duty to call special sessions upon the written request of the majority of the Sovereign Grand Inspectors General at such time and place as may be designated in their request. The date of a special session shall be not less than fifteen days nor more than sixty days after the date of summons except by unanimous consent, and notice of a special meeting shall be given by wire and followed immediately by formal written notice to each Sovereign Grand Inspector General.”

Our Supreme Council extends to all of the states and territories of the US except for the 15 states that it gave over to the Supreme Council of the Northern Masonic Jurisdiction. (These 15 states are: Connecticut, Delaware, Illinois, Indiana, Maine, Massachusetts, Michigan, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, Rhode Island, Vermont and Wisconsin.) And what is interesting is that our Supreme Council, in its Mother Council of the World role, claims jurisdiction over any Bodies of the Rite established in countries where there is no regular Supreme Council. (Art. II § 2.)
