PERSISTENCE-PRESS ON

To Be Free or Not To Be Free

A serious question for you — which is better, autocracy (absolute government by one person) or democracy (government by the whole population)? Please do not give a “knee-jerk” answer.

It is arguable that when the population as a whole are ignorant, uneducated, immoral, and illiterate — that is, unenlightened — autocracy is a better form of government than democracy, especially if the autocrat, or ruler, is benevolent and, himself, enlightened.

As Montesquieu showed, in the case of the “Troglodytes”¹, democracy without the guiding principles of morality and ethics can be far worse, even, than a benevolent autocracy. More recently, *The Lord of the Flies*, a novel by William Golding, took a look at freedom gone mad — freedom not guided by proper morality and ethics. It was not a pretty picture.

Greek notions of democracy, developed in the sixth century BC, were lost to Europe for more than a thousand years — from about 70 AD until about 1685 AD. During that time, autocracy prevailed. The all-powerful “Holy Roman Empire” endorsed “the divine right of kings”, while reserving for itself the role of final arbiter of Truth, in all matters. Truth was “Truth” only when the Pope had said that it was “Truth”. And, “Truth” was to be found only in “The Ancient Books” — the writings of St. Thomas Aquinas, of Boethius, of Galen, of Ptolemy, and (at the heart of it all) of Aristotle. Aristotle’s six treatises on the subject of “Logic” were known as “The Organon.” For about 1600 years, the Organon — as interpreted by Boethius and later by St. Thomas Aquinas — was “the last word” on “Truth”.

If Aristotle and Ptolemy said that the Earth was at the center of the universe (the point farthest removed from God) and that all the celestial bodies revolved around the Earth, in perfectly circular orbits, then there was no possibility that anything contradictory to this “Truth” could be anything other than heresy. There was no tolerance for questioning the “Truth” of “The Ancient Books”.

This state of affairs prevailed from 70 AD. until 1685 AD. Galen was “the last word” on human anatomy, as was Ptolemy on astronomy.

In one year, 1543, Vesalius showed that Galen was wrong about human anatomy, and Copernicus showed that Ptolemy was wrong on the subject of astronomy. Vesalius and Copernicus were largely ignored.

Ignorance was the rule; knowledge was limited to a few church clerics and a very limited number of aristocrats. Ignorance prevailed because books were scarce. Prior to 1450, books could only be written by hand, with quills, letter by letter, word by word, laboriously copied, usually by monks and other clerics of the church. Gutenberg’s 1450 invention, the printing press, made it possible to mass-produce books, so that knowledge became available to a broader audience — but only if they could read. And of course, very few people could read.

In 1606, the telescope was invented. In 1609, without the telescope, Kepler made the case that Copernicus was right and Ptolemy wrong, but he was ignored. In that same year, working with the newly-invented telescope, Galileo showed the same thing, but he, too, was ignored.

In 1620, Sir Francis Bacon published, “The New Organon”, in which he stated quite directly that Truth can only be found by the careful and methodical direct study of Nature, itself — not in any “Ancient Books”. Bacon was largely ignored.

In 1633, Galileo was arrested, charged with heresy, convicted, and placed on house arrest, because he had dared — with the Pope’s permission, mind you — to publish a comparison of Ptolemy’s ideas on astronomy with those of Copernicus. Galileo remained on house arrest from 1633 until his death in 1642. The Holy Roman Empire was quite serious in prohibiting any “Truth” other than its own — the “Truth” of “The Ancient Books”.

But the long-lost Greek notions of democracy were, in fact, re-discovered, when the European world came into contact with Persia. This occurred during the 17th century. For the preceding 16 centuries, the Persians has preserved and studied the wisdom of the ancient Greeks.

With the re-discovery by European peoples of the Greek notions of democracy, there emerged an inexorable movement toward individual liberty and away from “the divine right of kings” — away from the rule of church and state.

Thomas Hobbes, though, did not believe in democracy. He held that absolute rule by a king was entirely necessary, in order to avoid chaos, destruction, and collapse of the social order.

John Locke, Jean-Jacques Rousseau, The Baron de Montesquieu, and others too numerous to name believed in democracy, but they rightly recognized that ignorant and unenlightened free men will destroy themselves and their social order like bulls in china shops. They recognized that free men and women

Masonic Trivia

At one time, Golden Lodge #5, Stanstead, Canada occupied a lodge room, which straddled the boundary between Canada and the United States. There were entrances on both sides of the border.

Washington Chapter #3 of Portsmouth, New Hampshire announced its meetings via the town crier, who received from 6 to 25 cents for his work.

In 1872 the commissioner of Patents held that the Masonic emblem could not be used in a trademark or trade name for commercial purposes.

In *Hammer v. State*, 173 Indiana, 199 (1909), the Supreme Court ruled that it was a criminal offense to wear the emblem of any society or organization of which one is not a member. The court based its decision on the fact that the membership in such societies is the result of fitness and selection and that the wearing of such emblems by non-members is a deceit and false pretense.

In *Robinson v. Yates City Lodge*, 86 Illinois, 598 (1877), a court ruled that an expelled Mason was not entitled to the return of his degree fees. The court held that the plaintiff voluntarily paid the fees and the expulsion under the provisions of the rules of the organization does not constitute the rescission of a contract under which the fees were paid.

Frederick A Bartholdi, a freemason, designed the statue of Liberty in New York harbor. Grand Lodge of New York laid the corner stone on August 5, 1885.

Bernard Pierre Mangam, Marshall of France and Senator was appointed Grand Master of the Grand Orient of France and served from 1862 to 1865. This is unusual because he was not a Mason. He was appointed by Emperor Napoleon III.

The letters of the English word GOD are the first three letters of Hebrew words for beauty, strength, and wisdom. G in Gomez, O in Oz, D in Dabar.

In 1860 in Limerick, Ireland, there as found a stone in a small chapel, dated

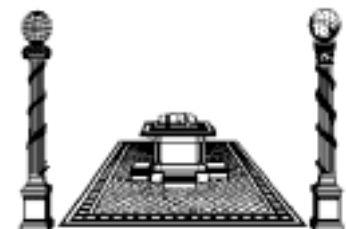
1517, with the following inscription: "I will serve to live with love & care, upon the level, and by the square."

Francis Stephens, the Duke of Lorraine, received the first two Masonic degrees in 1731 in a special lodge convened at The Hague, Holland, becoming the first known royal freemason. Later he received the third degree in England. In 1735 he renounced his title.

Dr. Joseph Ignace Guillotine was a member of Concorde Fraternelle Lodge of Paris and a member of the French Assembly. He obviously invented the device that bears his name and was later executed with one.

The Rev. William Dodd, first Chaplain of the Grand Lodge of England, was hanged for forgery on June 2nd, 1777.

In 1839 the Mormons left Missouri and settled in the area of Nauvoo, Illinois. On October 15, 1841, the Illinois Grand Master issued a dispensation to form a lodge at Nauvoo. On March 15th, 1842, Joseph Smith received his first degree and the others shortly after. Certain irregularities were reported - in five months the lodge initiated 256 candidates and 243 were raised. After investigation, the Grand Master revoked the dispensation, but the lodge continued to work. On April 5, 1844, the Mormon masons dedicated a Masonic Temple. Illinois Masons got in trouble for taking part in the ceremony. Opposition to the group and internal dissension led to the assassination of Joseph Smith and the removal of the Mormons from Illinois.

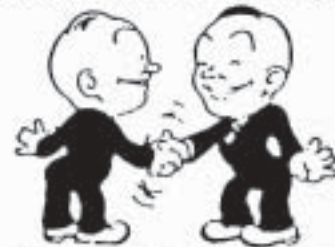

**Reflections On The Degree
of
The Intendant Of The Building**

***Believe as I believe no more no less;
That I am right (and no one else) confess.
Feel as I feel, think only as I think;
Eat what I eat and drink what I drink,
Look as I look, do always as I do;
And then and only then will I accept you.***

Years ago, while listening to a preacher on the radio, I heard him recite the little verse above during a discussion about the judgmental attitudes of some of his church members. I don't remember his name and, since I was jotting it down at about 70 miles per hour on I-95 between Norfolk and Richmond, I probably have somewhat misquoted him, but the idea is there. So, how does this fit into an essay on a degree that is concerned, primarily, with the virtues of honest labor? Well, stick with me on this one. As you may have noticed, I have approached these reflections on the Degrees of the Scottish Rite by trying to use the symbols of the Degrees to see past the obvious lesson of the particular degree.

The character, Satolkin has always interested me. As he approaches the throne of King Solomon he introduces himself as the Chief of the Carpenters and then adds that he has achieved the highest honors. This announcement is not made with bravado or self-aggrandizement. He does not see himself as better than others. He simply is the Chief of the Carpenters and has received the highest honors. That's just the way it is. It's a fact.

Satolkin knows that for all his authority and recognition he still must work with his peers Gareb, Zelac, Yehu-Aber, and Adoniram along with all who report to him and to them. I find no reference in the degree that tells me that Satolkin sought to learn the religion (there were, and are, more than a few sects

or philosophies within the Hebraic tradition) or politics of his peers and workers. He had to seek to know their integrity and diligence as these qualities were applied to their labor. He had to know their competence. He had to know that they could work as a team. He did not need to segregate his people according to their philosophy or culture. He only had to evaluate and direct their work together.

It is so easy to live in the past, which obviously, has no future. It is so easy to confine our intellect inside dogmas allowing us to never grow and expand. It requires very little effort to unite and inspire people *against* ideas or concepts. It requires much more of us to unite and inspire *for* ideas or concepts. This was Satolkin's great task; To unite his king, his coworkers, and subordinates in one great effort without petty bickering.

Many years ago my uncle, who was a farmer and also my Brother, told me, "If you want to move a wagon you have to hitch all your mules to the same end of it. If you hitch 'em all to different sides you not only will not move your wagon but you will most likely tear it up."

Our Brother Rudyard Kipling, in "Something of Myself," had this to say of his Masonic experience. "In '85 I was made a Freemason by dispensation (Lodge Hope and Perseverance 782 E.C.), being under age, because the Lodge hoped for a good Secretary. They did not get him, but I helped, and got the Father to advise, in decorating the bare walls of the Masonic Hall with hangings after the prescription of Solomon's Temple. Here I met Muslims, Hindus, Sikhs, members of the Arya and Brahma Samaj, and a Jew tyler, who was priest and butcher to his little community in the city. So yet another world opened to me which I needed."

Oh, that all Freemasons of all cultures, religions, and philosophies could rediscover an enlightened spirit and come together to build that "Temple not made with hands" and embrace one another in true Brotherly love. There are so many "worlds" that can be opened to us that we need if we seriously apply the lessons of Freemasonry. If we could, and we can if we are truly determined to do so, our Masonic wagon would never be overloaded and we could carry the world in it.

We must labor long. We must labor hard. We must labor with positive purpose. We must labor together. If not, we lose not only Freemasonry. We will surely lose the world.

Our two open meetings in March and April had excellent attendance. The dinner meals, prepared by Lisa Hollier, were one of the highlights as we have come to expect.

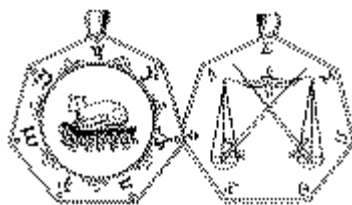

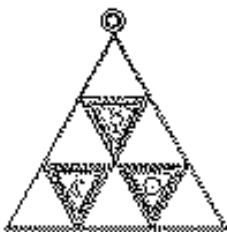

Our Valley was well represented at the Houston Leadership Conference.

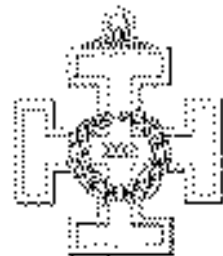

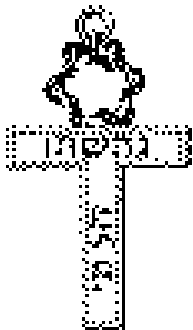

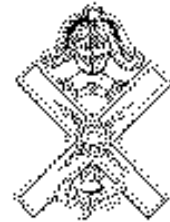
Knightly News

should be “enlightened” on moral and ethical issues, so that they will govern themselves properly. Enlightenment philosopher David Hume wrote, “Morality is a subject that interests us above all others. We imagine the peace of society to be at stake in every decision concerning it.”

The need to temper one’s freedom with ethical and moral concessions to the equal rights of others was called “The Social Contract”. Locke and Rousseau, for example, had much to say on the subject of “The Social Contract”.

Careful and deliberate efforts were made to “enlighten” men and women so as to make the emerging democratic civil societies successful. These efforts included “moral weeklies” — small tabloid-like weekly papers that were devoted to the discussion of specific moral and ethical issues. Also, “coffee houses” — new to Europe and growing out of its interaction with Turkey — served as a venue for open discussion of “enlightenment” issues, as did seminar-like gatherings in the salons of “the bourgeoisie”.

Very prominent among the modalities for the spread of Enlightenment ideals were the Lodges of Freemasonry. The Craft was crucially instrumental in preparing people for democracy, by spreading “enlightenment” on issues of morality and ethics. At a pivotal time in the history of Europe, Freemasonry was ready, willing, and able, to provide free men with the moral and ethical tools necessary to make the most of their new freedom.

The next time you hear someone say that “freedom” is what makes America great, you may want to count the spoons, before he gets too far down the road. What has made America great is enlightened freedom — freedom tempered by ethics and morality. Without ethics and morality, freedom is a destructive thing that weakens democracy, rather than strengthening it. Without ethics and morality, we would be better off (as Hobbes argued) governed by a monarch, with absolute power to make us behave properly.

Surely, though, enlightened democracy is the state of affairs that is to be desired above all others.

And Freemasonry remains, still, the principal repository of Enlightenment ideals. Let us do all that is in our power to assure that such will always be the case.

Where It All Begins

I am certain that everyone has one or more copies of the Petition For Degrees In Masonry at their immediate disposal. In the rare instance that you may have given your last petition to a prospect and haven’t secured another copy, there is one on the right hand page so that you might follow along.

Our Louisiana petition is similar in format to many Grand Lodge jurisdictions. The elementary information provided on the applicant’s petition is *where it all begins*. Therefore it is of the utmost importance that the data is correct and the questions asked be answered in their entirety. The Brother(s) that sign the petition should be the first proof reader before turning it into the Lodge. A most common mistake is on Question 3, what is your full name. Many times the petition only has a middle initial, instead of his middle name. Also, Billy Bob Jones could be in reality William Robert Jones. Although, I know a guy whose given name is Billy Bob. He filled out his petition as *Thursday* being his date of birth and place of birth was *Emergency Room*. He also checked all 4 lines on Question 5. I heard he is currently serving in the Grand Line of another jurisdiction.

The sparse information that is asked of the petitioner leaves a terrible void as far as personal information. He may indicate he is married, but isn’t asked for his wife’s name. He may have children, however the petition doesn’t request that information. He may belong to many civic and/or social organizations, but again, that isn’t revealed. At the Secretary’s desk, during the Entered Apprentice Degree, I use a *form* asking for spouse and children’s names with their dates of birth, anniversary date, cell phone numbers, E-mail addresses, civic organizations, schools attended and hobbies. Although this form serves a two-fold purpose, the information is invaluable and allows me the opportunity to introduce the new member to a mentoring brother with similar background and interests.

The petition asks for Social Security and Driver’s License numbers. Since September 11, 2001 it is increasingly difficult to secure background checks through our local law enforcement agencies. I have a firm belief that a new petition should include a release to have a check performed and the cost for the service be borne by petitioner. The fee would be attached to the release, forwarded to a company contracted to perform such services and the results provided to the Grand Lodge. The Grand Lodge could check their data base to see if the candidate had ever applied to a lodge in Louisiana in addition to adding the new petitioner to their base. I can already hear the groans and mutter of a few readers. “*Why I’ve known lil Jack since he was born*”... “*This is my nephew, you don’t need to check him.*” I truly appreciate those opinions. Before anyone goes postal, please read the disclaimer on page 2. I won’t draw your attention to being granted free reign.

Those active in our Rite have lamented our declining membership rolls. The Blue Lodges and their new petitioners are our strength and support. It all begins with the form on page 13. Without doubt, there is a friend or family member, that we each know, who would become a better husband, father, employer/employee and neighbor if he was provided a copy. Take a moment to discuss our Fraternity with these men. Replenish your supply of petitions and have them readily available.

tend this solemn and soul-searching ceremony.

The Extinguishing of the Lights' is followed by the Paschal Feast and then the ceremony of Relighting the Lights is presented to encourage all our Brethren to re-dedicate themselves to the Light achieved in the Scottish Rite. The tenets taught in the several degrees should be remembered and observed so that the public may recognize the higher morality of a Mason and especially that of a Scottish Rite Mason. 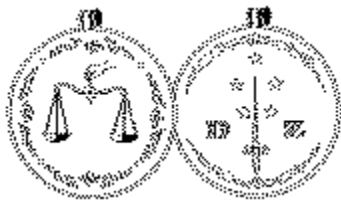

Are We Snobs?

Not too long ago someone told me that I was a snob for belonging to Masonry. The person said that all of us were snobs. I asked why and the person told me that we all set ourselves apart and thought ourselves better than others, when we really were just regular people. Well, being a person who really doesn't like to be "put down" for little or no reason, I went to my handy-dandy *Merriam Webster* and looked up SNOB. A snob is defined as – 1. a member of the lower classes, such as a cobbler; 2. one who blatantly imitates, fawningly admires, or vulgarly seeks association with those he regards as his superiors; 3. one who tends to rebuff, avoid, or ignore those he regards as his inferiors; 4. one who has an offensive air of superiority in matters of knowledge or taste. That took me down a few steps too. Hum-m-m? A snob? Well looking at each one of the defined areas, it seemed to me that none of the fine people who have crossed my path down the journey of Freemasonry were lower class, vulgarly seeking those who were considered superiors, ignoring those who might be considered inferiors, or being offensive by acting superior. Quite the contrary! Masonry welcomed me into its mysteries and gave to me men who became friends and Brothers, and who offered me mentoring, taught me generosity, helped me over obstacles in my life's journey, and impressed upon me the trait of service to others – always helping others. No; not a snob. However, I was drawn to another term – Elite. *Webster* again – 1. the choice part; 2. a socially superior group; 3. a powerful minority; 4. displaying leadership to others; 5. consciousness of being or belonging to such a group. YES - I am an elitist! All of those defined areas did represent much of my Masonry – being drawn to a choice group, belonging to a social (read – caring) group of great people, belonging to a powerful minority, always working toward the goal of being and displaying leadership, and being very conscience of being a Freemason – being aware every day. Not having run into *that* person since that original discussion has mellowed my enthusiasm for telling them to go look in their dictionary and see themselves somewhere between snivel and SNO-BOL. Then again, that would place me in a position of lower class activity, and I am a member of the elite. Just forgive and forget and move forward. So be careful when you call someone something that you may have thought was a "back-handed compliment" when in fact it was a back-handed slap. Masonry has taught me and offered me so much more of which to be thankful.

Words have always fascinated me and using them can be fun, yet challenging. Our words in Masonry have deep meaning and offer great lessons. But we don't do much to teach the words and their meanings – the true meanings. That made me realize that we as Masons, especially Scottish Rite Masons, are usually intellectually starving for more Light. A good and dear friend and Brother told me recently that our Scottish Rite meetings were trying to become entertainment for our members. He said that those people wanting to be entertained should stay home and watch

television. Coming to a Masonic meeting or event should be stimulating. He rightfully stated that we need to educate ourselves about Masonry – from the Lodge level and onward. Each month, our Grand Lodge Education Committee sends a one page education quiz to every Lodge in the monthly Grand Lodge mailing. I have often wondered how many Lodges actually use that quiz during a meeting to help educate the members present and stimulate them intellectually? It takes all of five minutes and usual provokes discussion on the questions in the quiz. What a wonderful tool, and how often is it used? Scottish Rite meetings should always be an educational and stimulating experience, as should the Degrees during a Reunion, as should our sitting and visiting before and after any Masonic activity. We tell everyone that Scottish Rite is the "University of Freemasonry", yet we are not offering any classes. Scottish Rite 101 should be offered to every new Master of the Royal Secret and then each man should move on to advanced courses. But who in your Valleys teach these courses? Who is the person selected by the Venerable Master at each meeting to give More Light? We must never fail to offer courses to our "university students". Today, more than ever, men are searching for something beyond their daily lives and recreational moments – Masonry has the answer, and Scottish Rite Masonry really has the answer – stimulating words set in Degrees that offer something of life's lessons, character building, honesty and integrity in dealing with others, respect for one another, cherishing values that have been protected and handed down through the ages – it is all there for the taking. Please ask for and require that each meeting offer the stimulation and education needed and sought after today. Do not settle for a meeting that only entertains and leaves us starving intellectually when we leave and head for home. Be an active member of our elite organization. Thank you for continuing to be an elitist and an active Scottish Rite Mason.

Did You Know?

32° Master of the Royal Secret:

The cap for a Master of the Royal Secret shall be circular style, 3-1/8 inches high, made of heavy black grosgrain silk. Band of 18 ligne No. 2180 black silk braid 1-1/4 inches wide finished, a cord welt above and below the band. One row of 3 ligne No. 1062 gilt vellum wire lace at top and bottom of band, leaving an interval 9/16 inch on band between the lace. On center in front a double-headed eagle 1-3/4 inches high with a red equilateral triangle 3/4 inch high, including rays, above the eagle. The total height of the eagle and rayed equilateral triangle to be 2-1/2 inches. The eagle of Nos. 29, 30 and 31 gilt bullion. The equilateral triangle to be of red cloth outlined with No. 3 gilt jaceron with figure 32 in center and rays outside of Nos. 25 and 26 gilt bullion embroidery. A regulation gilt bullion double overcord, fastened at lower edge of cap on each side with a gold-plated metal button, the latter embossed with a double-headed eagle emblem. Cap lined with black satin and interlined with muslin, the inner rim of buckram, with a leather sweat band.
